**Explanation of Responses:**

1. The reported transactions involved an amendment of the vesting criteria of an outstanding option, resulting in the deemed cancellation of the "old" option and the grant of a replacement option. The option was originally granted on October 4, 2011 and now provides for vesting on the earlier of (i) the first trading day after the company's voting common stock trades for more than 10 consecutive trading days at or above the closing price of \$0.80 and (ii) the day that a binding agreement is signed for the sale of the company as determined by the Board of Directors in its reasonable discretion.
